STANLEY THOMPSON

Stanley Thompson, the premier golf course architect of the 1920's and holder of the course record at the Peterborough Golf and Country Club, was engaged 1929-1931 to design an 18-hole layout. The original 6,300yard course had all the Thompson trademarks for strategic golf.

The bunkers were directional, and the mounds (mimicking the Peterborough Drumlins) deflected errant balls. The course snaked its way along the Trent-Severn Waterway in classic links style. Except for minor changes, the layout of the course remained virtually unchanged until 1990 when the Club rerouted its 4th, 5th and 6th holes.

Initiation Fee - \$4,000 + HST

Currently the club has an Initiation Fee of \$4,000 which can be paid over three installments. 40% is due with the application, 30% the following spring, and 30% the following spring. The second member of a couple at the club is subject to only 50% of the Initiation Fee.

Any change of membership category or cancellation of membership must be received no later than December 31 for Golf and Social memberships and September 30th for Curling Memberships.

In the event of a delinquent account any Member who fails to pay the prescribed Initiation Fee, Annual Fees, Capital Fees, House Minimum, or any other assessment or levy, or any other indebtedness to the Club within 30 days after the same is due, the Board may, without notice, withdraw all privileges of such member.

For any indebtedness past 30 days, the Club will charge members accounts a 2% service charge to avoid the withdrawal of my privileges.
